This is a certificate of integration into the primary care program "Travel Care" which offers you the possibility of health services according to the following benefits table.

BENEFITS TABLE

1. Unlimited and free charge medical visits.

The Health program offers you the possibility of unlimited and free of charge medical visits to outpatient clinics of contracted Hospitals, on all the available specialities.

2. Unlimited and free charge medical visits.

The health program provides unlimited and free of charge medical visits for Emergencies to outpatient clinics to the contracted Hospitals (attached file – Contracted Hospitals), on duty specialties (24 hours/day – 365 days/year): Pathologist, Cardiologist, Orthopedic, Surgeon, Pediatrician, Pediatrician-Surgeon.

3. Unlimited and free of charge medical visits in.

- i. Health program offers unlimited and free of charge medical visits to contracted polyclinics.
- **ii.** Health program offers unlimited and free of charge medical visits to contracted Nationwide network Of Private clinics.

4. Unlimited Diagnostic tests.

The health program provides unlimited diagnostic tests provided by Hospitals, Polyclinics and Diagnostic centers of our contracted network. The member's participation is based on the Official Diagnostic Exam National Price List.

5. Accidents expenses coverage.

Health program offers the possibility of coverage the **70%** of the expenses of an accident in outpatient clinics of collaborating hospitals and up to the amount of **200 euros** per incident.

Coverage expenses include:

- The remuneration of doctor performing medical action operation.
- Hospital charges for medical action.
- Sanitary material (stitches, plaster, splints, etc.) (Excluding drugs).

The member / insured person pays the rate of his participation (30%) directly to the contracted hospital.

6. Accidents Diagnostic tests coverage.

In case of an accident, **100**% of the expenses covered in outpatient clinics of collaborating hospitals and up to the amount of **300 euros** per incident.

7. Emergency incident.

In case that collaborating hospitals cannot be reached during the incident, **100%** of the expenses of an emergency incident covered, out of collaborating hospitals and up to the amount of **200 euros** per incident.

8. Free of charge annual blood check up.

The Health program offers a free of charge annual check up including ,Full blood Count, Red globules, ESR, Urinalysis, Glucose, Total cholesterol, Triglycerides Hepatic check (for programme members over 14 years old) including: SGOT, SGPT, Gamma-GT.

Performed by the contracted Hospitals and Diagnostic centers.

9. Free of charge annual ophthalmologic check up (for members aged over 14).

The health Program provides a free of charge, annual ophalmological check up including measurement of the visual acuity, Measurement of Refraction (refractometer), lit lamp examination (funduscopy).

Performed to the contracted Hospitals and ophthalmologic centers.

10. Free of charge annual dental check up, including:

The health program provides an annual, free of charge dental cleaning / polishing / fluoridation Precautionary Radiographic testing.

Performed to all prefectures of Greece to contracted dental centers and dental offices.

11. Dental coverage

Dental services that cover the area of therapeutic / surgical dentistry and the field of cosmetic dentistry with coverage up to **50%** on a specific price-list, common to all dental network centers.

12. Unlimited Physiotherapies

The health program offers unlimited physiotherapies with member's participation **15 euros/visit** provided by all contracted physiotherapy centers.

13. Medical Coordinating center (24 hours a day, 365 days a year)

Coordination (appointments) for program benefits use.

SPECIAL CONDITIONS/ PROGRAM GUIDELINES

1. START BEING IN FORCE

All coverage, which refers to BENEFIT TABLE, is activated three (3) days past Membership health Card's delivery.

2. DEFINITIONS

Member of Contracted Network: Every hospital/clinic or diagnostic center or Polyclinic or private outpatient clinic and any other form of medical, cooperating with the Company and provides health services to its members.

Medical visit: is considered the history taking, diagnosis, treatment recommendation and assessment of results of diagnostic tests that have been recommended.

Membership health Card: is considered the special card which is provided to the members by the company, showing the contract number, the start date of validity of the program and the full name of the member. The possessing and showing of the membership health card, with a proof of identification (ID card or other legalizing document) legalizes the use of the benefits of this agreement.

3. OBLIGATIONS

For effective and faster use of the program benefits the members should:

- a) Communicate with the Coordinating Call Center through which he will receive instructions regarding the coverage he wishes to activate.
- **b)** Provide the Membership Health Card of the subscription program and probative evidence of their identity, such as, indicatively mentioned, ID, valid passport etc. and facilitate the control of their identification, when it's requested within the framework of use of the program services by a member of the contracted network.

4. COMPANY'S LIABILITY

The Company bears no responsibility for the quality and accuracy, according to the rules of medical ethics and science, of the services to be provided to the member, on the basis of this subscription agreement, by the members of the Contracted network and their staff, as well as for the actions or their possible omissions.
